Subject: Resolution 486, LAIF Signature Authority

Crestline Village Water District has authorized the General Manager, Office Manager and the President of the Board of Directors as signers on the Local Agency Investment Fund account. As staffing changes occur, these signers are updated by resolution.

On August 6, 2021, Board President Connie Bracher-Griffin retired from her position on the Board of Directors, and a new Director will be appointed in the September regular Board meeting.

Staff recommends adopting Resolution 486, adding the newly appointed Director as an authorized account signer.
