PMIA/LAIF Performance Report as of 07/15/21



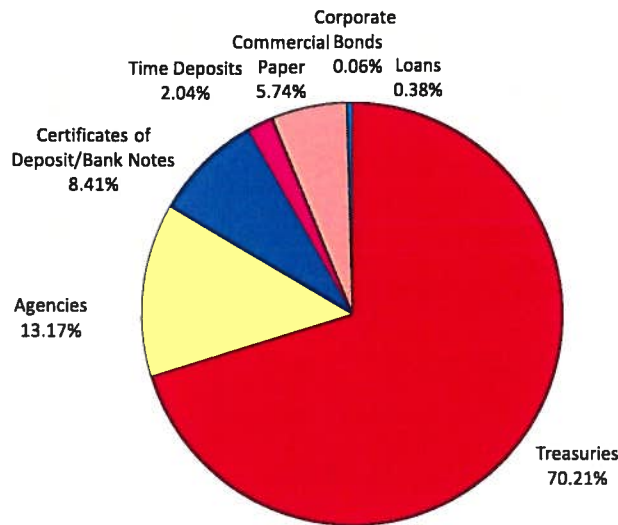
