While I have lived in Crestline since 2003, I spent my childhood in Lake Arrowhead. I bring to this open position a specialized skill set which includes my educational background, communication experience, research and reporting skills, public outreach skills, event planning/coordinating experience, and my presentation/media production expertise.

My educational background includes a B.S. in Information Systems (1991), a M.A. in Education with a concentration in Instructional Technology (1996), and a M.S. in Environmental Policy and Management with a concentration in sustainability (2012). In completing my M.S. in Environmental Policy and Management degree, I gained experience in developing plans that bring together opposing sides around controversial environmental issues, reading federal and state environmental codes/regulations, writing detailed response letters that include the review/summary of scientific data, and making formal presentations. I hold two Geographic Information System certifications, one from Penn State and one from Eastern Michigan University. I am also a California Naturalist with certification from UC Davis.

My work experience includes fifteen years of managing all aspects of instructional technology at the University of Redlands, three years managing a multimedia grant for the Claremont Graduate University, and many years of experience as an information technology consultant for CSU, San Bernardino.

As a person with a genuine appreciation for the preservation of natural spaces and the conservation of water resources, I decided to complete a second Master's program in the field of Environmental Policy. Presently, I am teaching an Introduction to Environmental Studies course for the University of Redlands. Through this course, we study water access issues given continued drought, climate change and its effects, and issues with increased pollution levels due methods of energy production and human choices. I am also familiar with the details of Urban Water Management Plans in that they include details such as sources for water, the service area, the function of the water treatment plants, water conservation actions, and need for contingency planning.

On a personal level, I have a strong commitment to community service. Listed below some of the volunteer activities I have been involved with over the past several years. All of these programs require a high level of dedication, coordination, and communication skills. In several cases, these are programs I initiated and have sustained over the years.

The students completed water quality testing of various lake locations, they mapped their data using Esri's ArcMap, and they developed a PowerPoint presentation of their findings.
- Organizer of Geography Kid Camp, a one-day summer camp serving children from elementary schools in the Redlands Unified School District, 2006-present.
