PMIA/LAIF Performance Report as of 07/09/20



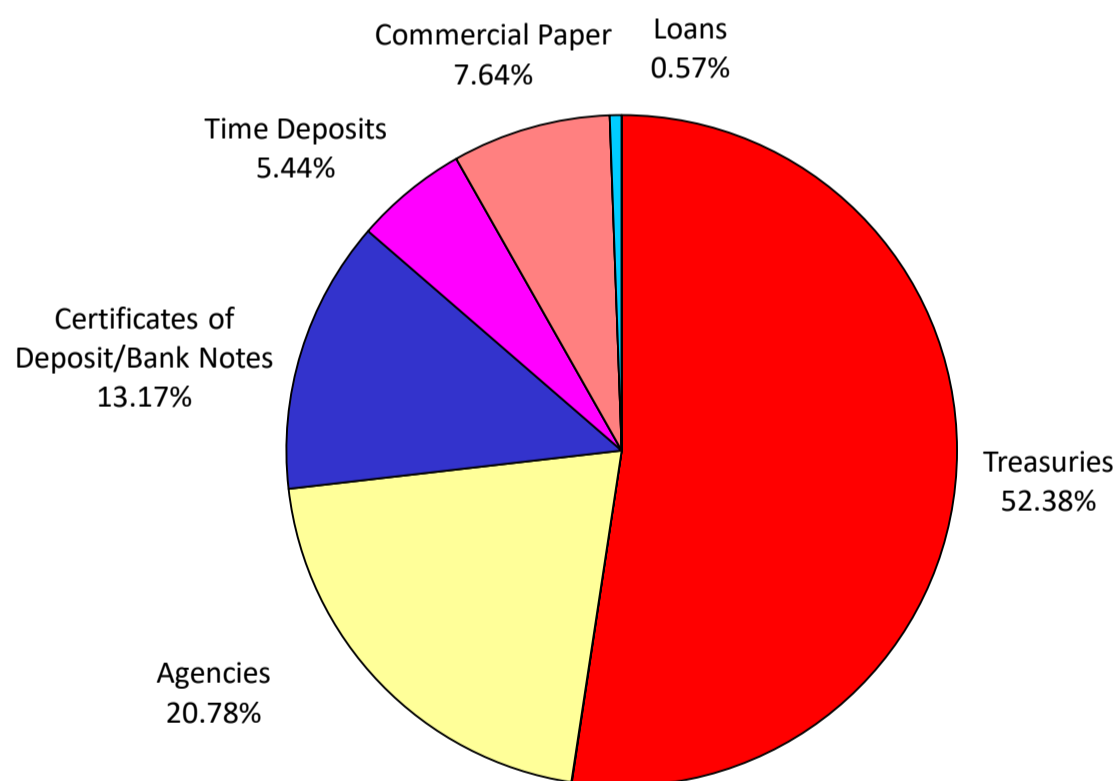
